## **Compstat Analysis**

As of Sunday November 01, 2020, in the Bronx:

- There were 17,021 index crimes which are up 3.8% from this time last year.
- There were 93 Murders which are up 24.0% from this time last year.
- There were 275 Rapes which are down -20.3% from this time last year.
- There were 2838 Robberies which are down -4.5% from this time last year.
- There were 4920 Felony Assaults which are down -2.6% from this time last year.
- There were 2221 Burglaries which are up 33.0% from this time last year.
- There were 5018 Grand Larcenies which are down -4.9% from this time last year.
- There were 1656 GLAs which are up 64.6% from this time last year.
- Year to Date, 21.5% of index crimes in the city occurred in the Bronx.

#### SUMMARY

AO and Ps in uniform and unmarked car assigned to public safety. AO observed defendant walking with a fanny pack strapped across his chest. AO observed a heavy, L shaped bulge in the fanny pack. D was walking towards AOs car and AO further observed the bulge. D then grabbed the bulge/fanny pack and tried to put the fanny pack under his arm. D then turned around and ran.

SGT and PO Miret exited the vehicle and began chasing D on foot. AO and PO Miggliachofollowing D in car. D was trying to remove the fanny pack. D eventually got it off, unzipped it, dropped items, continued running, then tossed the fanny pack. When d threw it the firearm came out of the fanny pack and AO heard a loud bang.

PO Miggliacho exits the car and recovered the gun and bag.

AO observed D run towards 166 but then loses sight. SGT doesn't lose sight of D and observed D enter 750 east 166th. SGT found D in the basement boiler area between 2 walls.

D arrested.

PO Correa transported D.

AO recovered the other dropped items from the street including marijuana and edibles.

SILA:

1 .380 caliber pistol with 1 round in chamber and 2 in magazine

5 paggies (3 orage, 2 silver) and 1 tube of weed

8 bags of THC edibles (gummies - 2 weed tarts, gummy sharks, 2 dank gummies, 2airhead extreme)

NYPD video statement: I GOT ROBBED IN THE MORNING. I HAD THE FIREARM. I KNOW WHERE THEY HIDE THE FIREARM. I WENT TO GET IT FROM THERE. I WAS TRYING TO ROB THE PERSON WHO ROBBED ME.

#### D and Sep-app individual menaced CWs and then stole their personal belongings..

AT TPO: Defendant , arrest # (red hoodie and red pants and blue jacket) and Defendant (wearing black), approached the two CWs, they engaged in a conversation, they asked the CWs arrest # whether they belonged to Bloods. While acting in concert, Defendants asked the CWs whether they have any money on them, stating in S+S YOU HAVE ANY MONEY ON YOU? Asked whether they have cell phones and what kind of cell phones, stating in S+S: YOU HAVE A CELL PHONE? WHAT KIND OF CELL PHONE? Asked CW whether he had money on his debit card, asking in S+S: YOU HAVE MONEY ON THAT CARD? Defendants demanded money from the CWs. When CW said he has nothing of value, D stated to CW in S+S: YOU BETTER NOT BE LYING. When CW pulled out the \$2 bill D said to CW in S+S: WE WILL TAKE THAT. JUST GIVE IT TO MY FRIEND. From CW \$20 taken, from CW \$2 bill taken. After taking money, Ds walked away.

COA: NYPD responded to a report of a robbery. Officers canvased the area with CWs, point out ID.

D is observed on video surveillance outside of his apartment building shooting two shots from a silver pistol into the air. D is then observed going into the lobby of the building and showing witness anthony powell the firearm. D is then observed going into the elevator, then about to exit the elevator on his floor, and insteads decides to stay in elevator in take it to the top floor. D is wearing a black hoodie with red writing. D is then observed going down the elevator in a white t shirt.

When D gets down to lobby, responding officers who responded to a shot spotter are there and D speaks to officers with witness powell, stating they didnt see anything.

two .380 shell casings are found on the ground outside of the building and ECT responded.

Detective is assigned case, gets video surveillance, video clearly shows D shooting two shots into the air. DET then goes to **DET** knows **DET** (DET knows **DET**), **DET** wife answers apartment, they show her a still and ask if they know D, she identifies him and tells apartment number. DET then gets a photo from a previous arrest, matches D from video. DET then goes to apartment and D is there, they take him into precinct.

At Precinct D has full confession. Also identifies himself in photo still.
