

1.	1/16/2020 - At about 1528 hours,  were involved in an argument in front of 178 Avenue C.  pulled out a firearm and fired one shot into the ground and fired a second shot, which struck in the abdomen. The first shot ricocheted and grazed  (44 y/o) in the back of her left thigh.  fled. See NY. ADA  (TB80). 9 <sup>th</sup> Precinct.		
2.	3/8/2020 - At about 0500 hours,  chest inside of 716 East 6th Street ( <b>LES II</b> ). When pushed arm away, pulled the trigger. The bullet struck in the leg and shattering is leg bone, which required surgery. One live round was found in front of 724 East 6th Street and one shell casing was recovered from the 3rd floor hallway of 716 East 6th Street. See NY. ADA (TB60). 9 <sup>th</sup> Precinct.

1. 1/1/2020 - At about 0345 hours, Police Officers responded to a report of shots fired in front of 120 East 4th Street. As they approached they heard 3-5 additional shots fired. Police
