

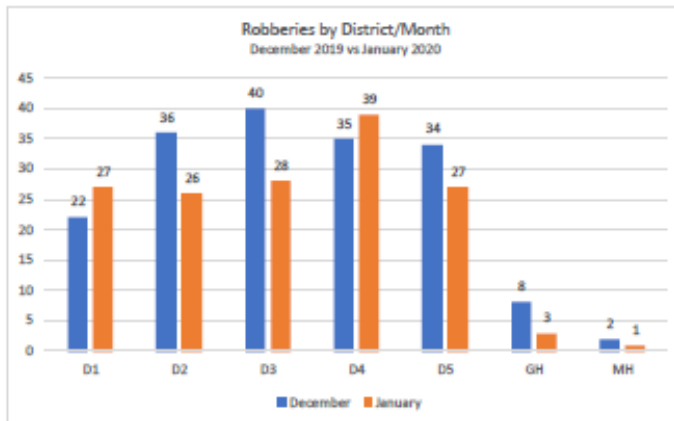

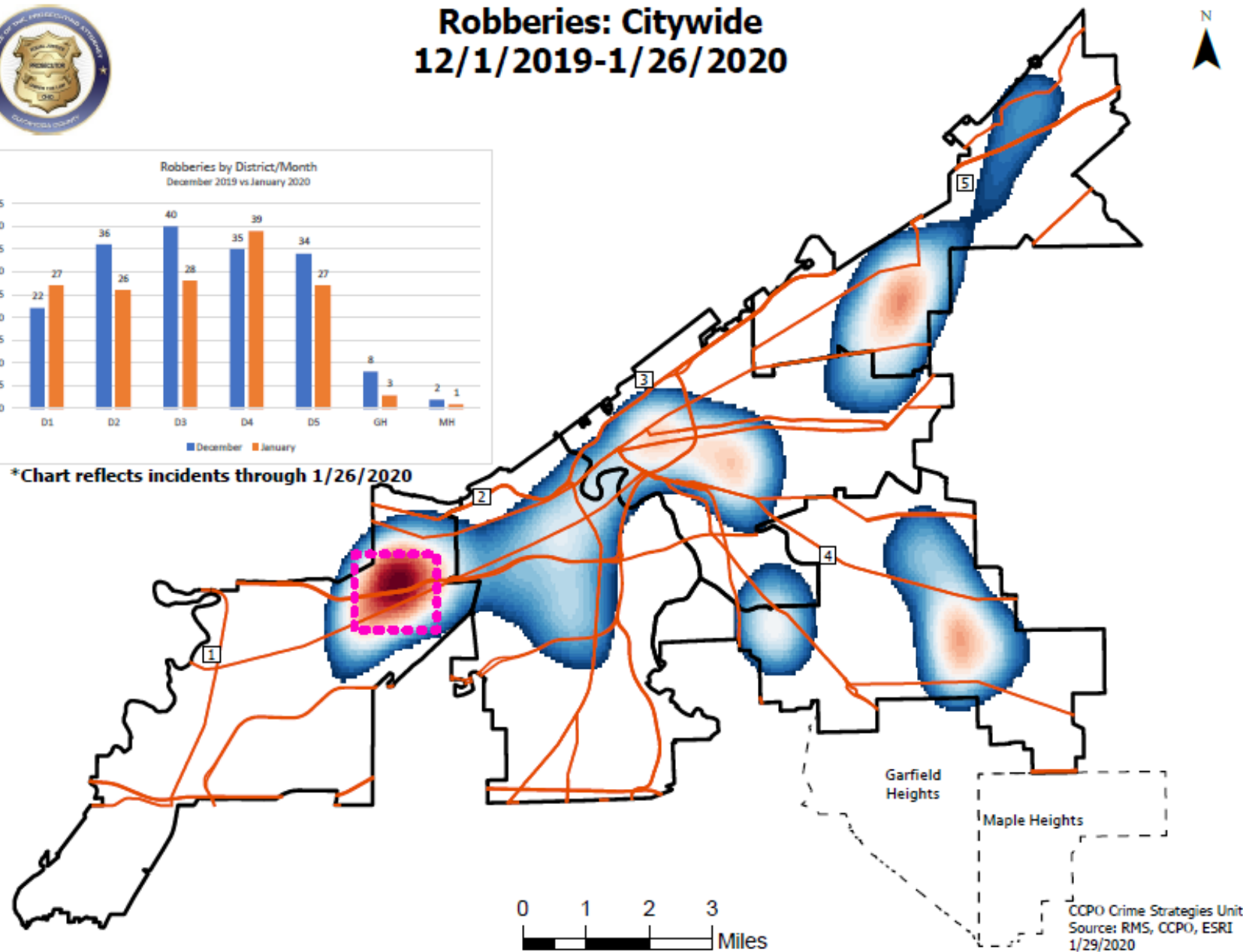

Robberies: Citywide 12/1/2019-1/26/2020



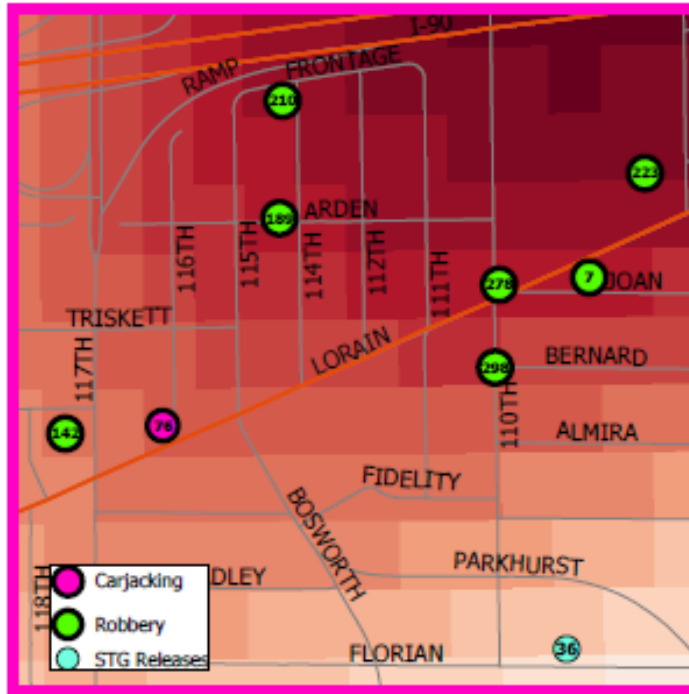

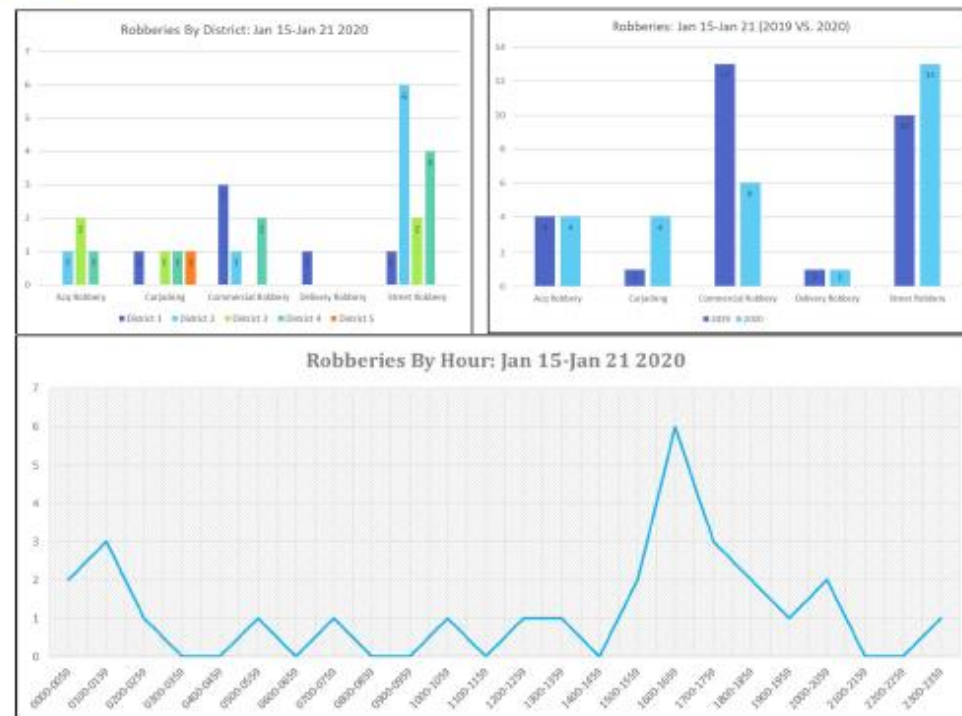

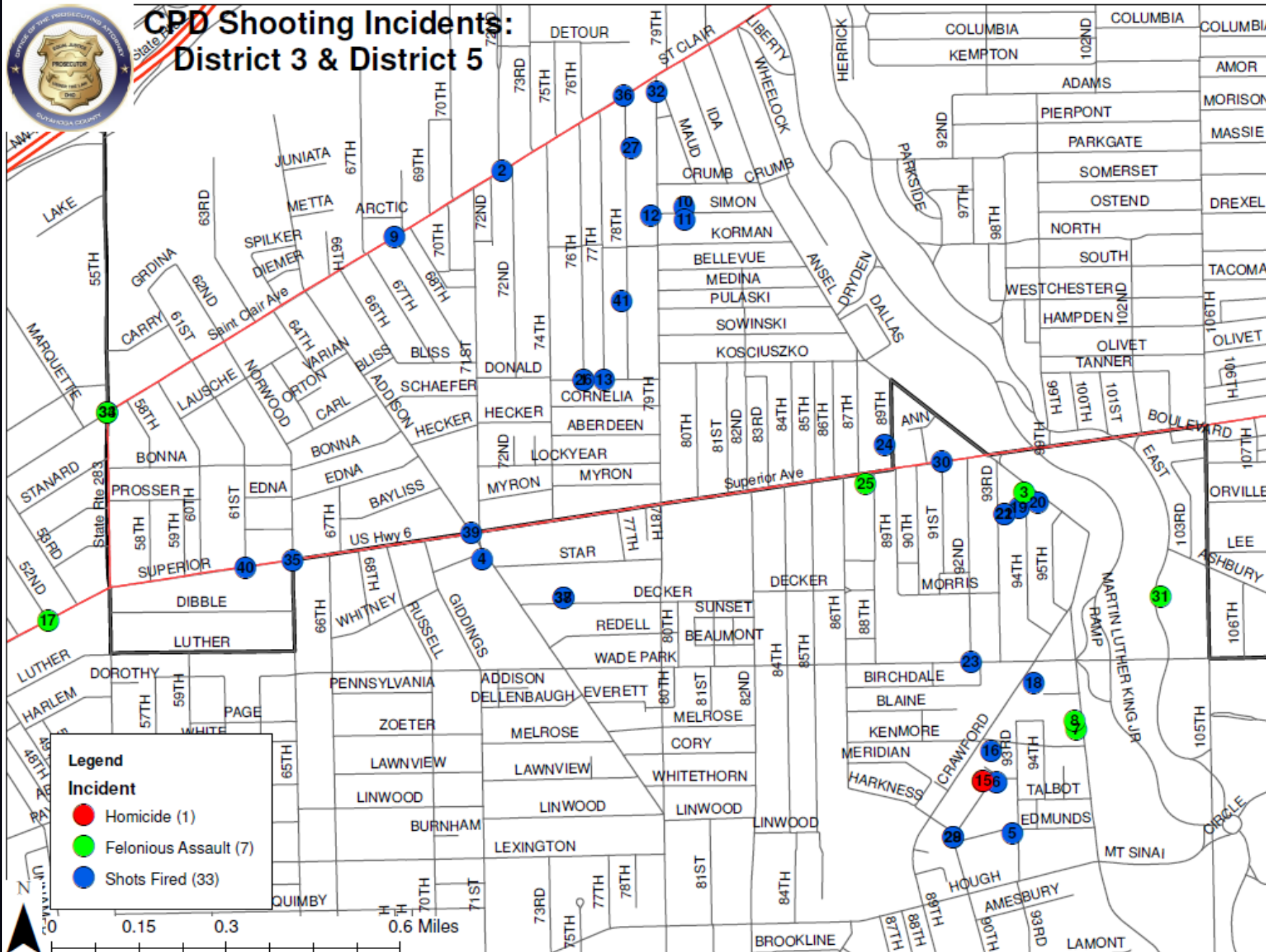

- **Narrative:** Vic 2 (Virginia Cowart 3/21/96) stated Susp1 (B/M, blk Adidas pants, blue champion hoodie, face completely covered, no gloves on, carrying a blk drawstring backpack) and Susp2 (B/M, navy blue Nike pants, blk Nautica hoodie, yellow/blk mask w/ upper face showing, blk/yellow Jordan shoes, white gloves on) entered the store with blk guns, demanding money. Susp1 pointed a gun at Vic2 and demanded the money out of the drawer while Susp2 stood at the front door as a lookout. Susps then exited the store and fled. Susps threw out the money tracker on E 117th St & Buckeye.

- **Follow Up:** Det. spoke with Virginia Cowart on 1/18/20 who stated the lookout suspect was wearing a red bandana and white gloves and the gunman was wearing a black mask and was not wearing gloves.

- **Narrative:** Vic 2 (Renea Saffo 3/15/82) stated Susp1 (M, wearing all blk, white gloves) and Susp2 (M, white/blk hooded flannel, drk pants, light colored shoes, small silver gun) entered the loc through the back door. Susp2 ordered Vic2 to the back office and forced her to open the safe and give him all the money. Susps then fled out of the back door. RP [Tyronne Coleman 1/11/70] stated he just fired a female (Kirsten Brown) for stealing and she recently fell on hard times. The female made statements about having her BF [Charles Bilal] rob the place.
