## Jacksonville, Florida

Stephen Siegel  
First Assistant State Attorney of the Fourth Judicial Circuit  
Jacksonville, Florida

Stephen Siegel has spent his legal career serving the people of the Fourth Judicial Circuit in a variety of roles before being named First Assistant in January 2017.

Siegel began his career with the State of Florida as a Judicial Staff Attorney. He joined the State Attorney's Office in 1995 and during his tenure with the office has served as a division chief in both Circuit Court and County Court. He most recently served as senior division chief of the Nassau County office.

His career with the office also includes being named a division chief in the office's Special Prosecution Division, where he initiated complex investigations and prosecutions of white collar and economic crimes, fraud, arson, environmental crimes, and public corruption cases.

In 2004, Siegel became board certified by the Florida Bar in Criminal Law. He was the second prosecutor in the Fourth Judicial Circuit to attain the distinction.

As First Assistant, Siegel is responsible for overseeing the legal division, business operations, IT, human resources, and office administration.

He graduated from the Washington and Lee University School of Law, where he served as chairman of the Moot Court Board, and received a bachelor's of science degree from the University of Louisville.



## King County, Washington

Dan Clark  
Chief Deputy Prosecuting Attorney (Criminal Division)  
King County, Washington

Dan Clark is the Chief Deputy for the Criminal Division of the King County Prosecutor's Office, overseeing a division of over 300 lawyers and staff. Dan joined the office in 1996 after graduating from UCLA Law School and Tufts University. In his time at the King County Prosecuting Attorney's Office, Dan has served as a trial attorney in various units including District Court, Juvenile, Narcotics, Domestic Violence, and Violent Crimes. Dan also served nearly 4 years in the Appellate Unit arguing cases before the Court of Appeals and the Washington State Supreme Court. In 2007, Dan spearheaded a committee to draft the first written Brady protocol for the King County Prosecutor's Office. The protocol was the first of its kind in Washington and has since been adopted as a state model policy. Dan has chaired the Brady/Potential Impeachment Disclosure (PID) Committee ever since. Dan has served as a supervisor since 2002, serving first as the Chair of the Narcotics Unit, and then the Chair of the Violent and Economic Crimes Unit. For 13 years Dan served as the Managing Attorney at the office's satellite office and the Assistant Chief of the Criminal Division. Dan was promoted to Chief Deputy in December 2019.

David Baker is a Senior Deputy Prosecuting Attorney and the Data Analytics Manager for the Criminal Division of the King County Prosecuting Attorney's Office. David joined the office in 2009 after graduating from Seattle University Law and the University of Washington.

In his time at the King County Prosecuting Attorney's Office, David has served as a trial attorney in various units, handling a variety of types of cases including murder, sexual assault of adults and children, domestic violence, violent crimes, property crimes, and DUI.

David has served as the Data Analytics Manager since late 2018. In that role he has revolutionized how the office utilizes its case management system, analyzes its data, and makes use of it. David also developed and maintains the office's [Public Data Dashboard](#), which went live in 2021.

Oren joined the DAO in 2018 to use analytics, research, and criminological theory to plan and implement policy to transform Philadelphia's legal system. At the DAO, Dr. Gur has been a PI or Co-I on more than \$4.86 million in foundation grants, including to create the DATA Lab, a new unit that supports policy, practice, and research into the impact of prosecutorial discretion on individuals and communities. Oren has worked on prosecutor-led bail reform, sentencing reform to reduce mass supervision, decriminalization of buprenorphine and fentanyl test strip possession, and expediting the adjudication of nonfatal shooting cases, and facilitated independent research on topics including bail reform, accidental drug overdoses and criminal justice contacts, and the resentencing of juvenile lifers.

Michael Hollander

As the DAO's Director of Analytics, Michael Hollander helps to oversee the analysis conducted by the DATA Lab and helps to guide and maintain our relationships with the Executive and Policy teams, DAO staff, and outside researchers. His role ranges from helping to lead and measure policy change to performing discrete analyses to helping with policy implementation. Mike came to the DAO after 10 years as an employment lawyer at Community Legal Services where he spent his time handling individual cases and working for systems change on issues related to immigrant workers' rights issues and the barriers to employment posed by criminal records. He came to the DAO to help DA Krasner reform the criminal justice system using data, compassion, and a deep understanding of poverty. Mike graduated Order of the Coif from the University of Virginia School of Law in 2008; he also received his BS in Systems Engineering from UVA in 2001.

Wes Weaver is the Assistant Supervisor of Analytics at the Philadelphia District Attorney's Office (DAO). In 2019, he co-created the DAO's Public Data Dashboard and helped start the District Attorney's Transparency Analytics (DATA) Lab. He holds a Master's of Urban Spatial Analytics from the University of Pennsylvania and has a background in spatial data analysis and economic justice. Prior to working at the Philadelphia DAO, Wes worked as a labor and community organizer, and as a geospatial analyst in the aerial survey industry, including projects for the U.S. Department of Agriculture, the U.S. Geological Survey, the National Oceanic and Atmospheric Administration, and Microsoft's Bing Maps.

Jonathan Raven  
Chief Deputy District Attorney  
Yolo County, California

Jonathan Raven is the Chief Deputy at the Yolo County District Attorney's Office, an office with approximately 40 prosecutors, and runs the day-to-day operations of the office. He received his law degree from Loyola Law School in Los Angeles in 1991 after graduating with honors from the University of California Santa Barbara in 1986. Among other divisions, Raven supervises the Mental Health Court and Addiction Intervention Court teams. Raven is a member of the statewide "Prosecutor Diversity" committee where District Attorneys' offices have begun to focus increased efforts on recruiting more diverse law students and graduates. In March, 2019, Raven was appointed by Yolo County Supervisor Jim Provenza to the Local Mental Health Board. Raven is an adjunct professor at UC Davis King Hall School of Law teaching trial advocacy since 2005. He is also an instructor at the Museum of Tolerance in Los Angeles where he trains officers on the POST-mandated racial profiling course. In May, 2013 Mother's Against Driving (MADD) honored Raven with their Statewide Prosecutor of the Year award.

Kristine Hamann is the Executive Director and founder of Prosecutors' Center for Excellence (PCE). PCE provides consulting and research services for prosecutors to promote best practices, spur innovations and implement solutions. From 2013 to 2016, Kristine Hamann was a Visiting Fellow at DOJ/Bureau of Justice Assistance where she worked with prosecutors in over 30 states. She chairs the NY State Best Practices Committee for prosecutors and teaches at Georgetown Law School. She is a member of the American Bar Association (ABA) Criminal Justice Council and is on the ABA Criminal Justice Journal Editorial Board. From 2008 to 2013, Ms. Hamann was the Executive Assistant District Attorney for the Special Narcotics Prosecutor for the City of New York. From 2007 to 2008, Ms. Hamann was the New York State Inspector General. From 1998 to 2007, Ms. Hamann served as the Executive Assistant DA to DA Robert Morgenthau in the Manhattan District Attorney's Office in New York City. Prior to 1998, Ms. Hamann held a number of other positions in that office including Deputy Chief of the Trial Division and Director of Training. She started her career as a violent crime prosecutor. She has received various awards for her public service.

Sophia Roach

Senior Attorney

Prosecutors' Center for Excellence

Sophia Roach was a prosecutor in the San Diego County District Attorney's Office (SDCDA) for 23 years, where she assisted in the management of four divisions, issued and prosecuted over 600 vertical gang, narcotics, and family protection cases, and prosecuted 77 jury trials to verdict, including 11 murder cases and oversaw large scale investigations and wiretap projects. Ms. Roach is an expert in gang prosecution, the development of informants, protecting confidential information and vulnerable witnesses, complex wiretap investigations, inclusive *voir dire*, and elimination of bias in prosecution work. She is a veteran instructor of lawyers, law enforcement, and students at both the law school and collegiate level. She also served as an in-house Ethics Advisor from 2010-2021.

Ms. Roach previously served as a liaison to the FBI Violent Crime Task Force, the East County Gang Task Force, the Jurisdictions United for Drug and Gang Enforcement Task Force, and the San Diego Crime Laboratories. She was a training advisor for the California District Attorneys Association Narcotics Section, a member of the SDCDA Legal Training Advisory Board from 2009-2021, and the advisory board for the SDCDA Committee on Race and Equity.

Ms. Roach helped form the NDAA Women Prosecutors Section, San Diego Women Prosecutors, and Power League, a school based SDCDA outreach program. She served on the board of directors for the California District Attorneys Association and the San Diego Deputy District Attorneys Association, which awarded her their 2009 "Outstanding Prosecutor" and 2019 "Prosecutor of the Year" awards as well as two service awards. Ms. Roach has received 3 FBI Director Commendations and numerous other local law enforcement commendations.

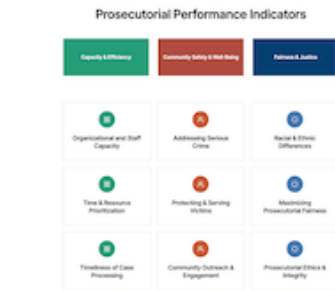

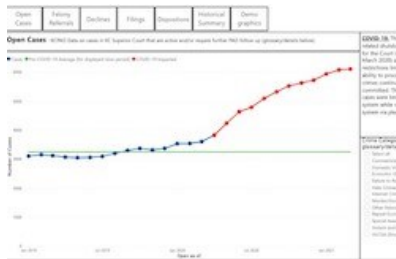

## Instructions to Receive CLE Credit

### Please Read Carefully

The Prosecutors' Center for Excellence has not requested continuing legal education accreditation for this program. Instead, we will supply you with a **Uniform Certificate of Attendance**. This certificate will include Prosecutors' Center for Excellence (PCE) as the sponsor, the title of this conference, the dates of this conference, the location of this conference as well as a calculation of the CLE Credit Hours under both a 60-minute and 50-minute hour system. We believe that these hours accurately reflect the CLE credit you should receive. However, each state has its own rules on the accrediting process which could affect this calculation.

**At the end of each session, you will receive a conference evaluation. You will need to fill out the survey in order to receive the **Uniform Certificate of Attendance**.**

As part of the meeting materials, PCE will supply you with this meeting's agenda, a description of the various content to be covered throughout this conference, as well as the names and biographies of the speakers.


