




Speaker Biographies and Photos

Thomas Abt

Senior Fellow, Council on Criminal Justice and Chair, Violent Crime Working Group



Thomas Abt studies, teaches, and writes about the use of evidenceinformed approaches to address violent crime and other public safety problems. He currently chairs the Council's Violent Crime Working Group and recently directed its National Commission on COVID-19 and Criminal Justice. Prior to joining the Council, Abt served as a Senior Research Fellow at the Harvard Kennedy School and held leadership positions in the New York Governor's Office and the Office of Justice Programs at the U.S. Department of Justice. Abt is the author of Bleeding Out: The Devastating Consequences of Urban Violence - and a Bold New Plan for Peace in the Streets, published in June 2019. His work has been featured in media outlets including the Atlantic, the Economist, the New Yorker, the New York Times, the Wall Street Journal, the Washington Post, CNN, MSNBC, PBS, and National Public Radio.



District Attorney Sherry Boston

DeKalb County, GA



Sherry Boston stands among the elite in the world of prosecution as one of the rare one-percent of African-American females currently serving as District Attorney nationwide.

Ms. Boston assumed the role of District Attorney for the Stone Mountain Judicial Circuit in January 2017. In her capacity, DA Boston oversees the prosecution of felony offenses filed in the Superior Court of DeKalb County and supervises a staff of more than 200 individuals, including attorneys, investigators, paralegals, victim-witness advocates, and administrative professionals assigned to various divisions.

Since taking the helm as District Attorney, Ms. Boston has assembled a diverse and highly experienced leadership team to assist with restructuring and redefining prosecution processes to include the

development of new units and the consolidation of others. The Office has also increased its capacity to serve victims with an expanded victim services unit.

Observers have taken notice of DA Boston's efforts. She was recently lauded by Atlanta Magazine as one of metro Atlanta's 500 Most Influential People, earning the coveted front cover of the publication. Through her work with the Institute for Innovation in Prosecution and the Fair and Just Prosecution initiative, DA Boston has also become an integral part of the national dialogue on criminal justice reform and innovative prosecution strategies specific to juvenile justice, reentry, and accountability initiatives. DA Boston is one of four top prosecutors recently named to the GRACE Commission, a statewide task force created by Georgia's First Lady to combat human trafficking.

Prior to her role as District Attorney, Ms. Boston served as DeKalb County Solicitor-General, the elected prosecutor overseeing misdemeanor crimes. During her tenure as Solicitor-General, Ms. Boston was instrumental in the development of DeKalb's revamped Traffic Division and also implemented a wide variety of innovative programming and strategies aimed at community outreach and crime prevention.

In addition to her elected positions, DA Boston has received numerous legal appointments and wide recognition for her innovative prevention/intervention initiatives and impassioned commitment to domestic violence awareness. In 2018, she received the Champion for Change Award from the Women's Resource Center to End Domestic Violence for her leadership in the DV arena, including the development of two signature community awareness campaigns.

Among her varied involvement in community and legal organizations, District Attorney Boston is an active member of the State Bar of Georgia where she serves on the Disciplinary Board, which has the power to investigate and discipline members of the State Bar for violations of Standards of Conduct. District Attorney Boston also serves on the Board of Governors, the State Bar's policy-making arm.

District Attorney Boston is a graduate of Villanova University in Philadelphia, Pennsylvania and Emory University School of Law. She resides in DeKalb County with her husband and two daughters.

District Attorney Alvin Bragg

New York County, NY



Alvin Bragg is the 37th District Attorney elected in Manhattan. Alvin – a lifelong Manhattanite who served as a state and federal prosecutor – has spent more than two decades fighting to make our communities safer and our criminal justice system fairer.

Alvin served as an Assistant Attorney General at the New York State Attorney General's Office and as an Assistant U.S. Attorney for the Southern District of New York. In these roles, Alvin handled a wide array of criminal cases, including armed robbery, assault, gun possession, witness tampering, narcotics and gun trafficking, wage and hour violations, public corruption, money laundering, and antitrust violations. For example, he successfully prosecuted a bribery scheme involving corrupt politicians of both political parties, the owner of a multi-million dollar business for laundering millions of

dollars for an international drug cartel, an FBI agent for making false statements, a government contractor for diverting approximately \$1.7 million designed to provide internet access to public school classrooms, and individuals blocking a reproductive health facility.

From 2013 to 2018, Alvin served in a number of leadership roles at the New York State Attorney General's Office. He ended his service there as the Chief Deputy Attorney General in New York State, overseeing more than 1,500 people, a budget of \$225 million, and the office's criminal and civil investigations and litigation, including health care fraud, public corruption, narcotics trafficking, wage-and-hour investigations, tenant harassment, and securities fraud. In addition, he served as the first Chief of a special unit that investigated deaths caused by police conduct.

Alvin earned his A.B. from Harvard University, a J.D. from Harvard Law School, clerked for Hon. Robert P. Patterson, Jr. in the Southern District of New York, and was a Visiting Professor of Law and Co-Director of the Racial Justice Project at New York Law School. Alvin is a former member of the Board of Directors of the New York Urban League and a Sunday School teacher at his church.



Director of Community Violence Intervention

Samuel Castro

Institute for Nonviolence Chicago, IL



Samuel Castro has been doing outreach work for over ten years with a variety of organizations. He was an Outreach Worker with Nonviolence Chicago prior to being promoted to Outreach Program Manager. Now in his current position of Director of Community Violence Intervention he oversees Outreach and Victim Services. Sam is a motivated leader who believes in others and always pushes himself and his team to perform at a higher level. The last time Samuel was incarcerated, he spent 12 years in custody. Upon release, he began working to turn his life and community around. He is close to his children and family and is truly an example of growth and change.


Executive Assistant District Attorney Kerry Chicon

Bronx County, NY



Kerry Chicon is an Executive Assistant District Attorney and serves as the Chief of the Strategic Enforcement and Intergovernmental Relations Division in the Bronx County District Attorney's Office. The division supports investigations, prosecutions, and just outcomes in the office, by employing data-driven policies and strategies, intelligence-driven prosecution, diversion to programming and treatment, technological and forensic innovations, and community engagement. The division is comprised of the Community Justice Bureau, Community Affairs Unit, Crime Strategies Bureau, Forensic Science Unit, Strategic Planning & Analytics Unit, Technical Investigations Bureau, the Information Technology Bureau, and Intergovernmental Relations. Prior to joining the Bronx DA's Office, Kerry served in the Manhattan District Attorney's Office for over 18 years, where she was the Chief of the Crime Strategies Unit, Deputy Unit Chief, Criminal Court Supervisor, and a street crimes prosecutor. She has planned and convened several national and local conferences

on intelligence-driven prosecution, innovations in prosecution, violent crime reduction strategies, and mental health in the criminal justice system. She has spoken at conferences all over the country and assisted other offices to create crime strategies units. She is the 2020 recipient of the Robert M. Morgenthau award. Kerry is a graduate of The Maxwell School of Citizenship and Public Affairs at Syracuse University and Brooklyn Law School.



County Attorney John Choi

Ramsey County, MN



John Choi was sworn in as the first Korean-American chief prosecutor in the country in 2011. Since taking office, John has become a state and national leader in progressive justice reform, working with public officials and impacted communities to reimagine justice and the role of prosecutors. John's innovative approach to holding abusers accountable, while working collaboratively with advocacy agencies to help victims, has transformed the way government intervenes in domestic violence and sex trafficking in Minnesota. John is now determined to do the same for victims of sexual assault. In addition, John has been a champion of raising boys and engaging men to prevent violence against women and girls; successfully advanced legislation to reunite families when it's in foster children's best interest; developed the use of lethality assessments and GPS technology to keep domestic violence victims safe; increased second chances by diverting people before they are charged; successfully advocated to reform state drug laws and reinvest savings in community-

based solutions; and established a Veterans Court. John serves on the boards of the Minnesota Coalition Against Sexual Assault and Mitchell Hamline School of Law, is past president of the Minnesota County Attorneys Association and past trustee for the Women's Foundation of Minnesota.

John received the 2015 Minnesota County Attorneys Association Award of Excellence for his innovative leadership in better prosecuting sex traffickers and helping trafficked children. Previously, John served as Saint Paul City Attorney (2006-2010) and spent a decade in private practice. John holds a bachelor's degree in Psychology from Marquette University, a J.D. from Hamline University School of Law, and was a Humphrey Fellow at the University of Minnesota.



District Attorney Darcel Clark

Bronx County, NY



Darcel Denise Clark became the 13th District Attorney for Bronx County on January 1, 2016. She is the first woman in that position and the first African-American woman to be elected a District Attorney in New York State. She was re-elected to a second term in 2019.

District Attorney Clark's mission is "Pursuing Justice with Integrity," and in fulfilling that mission she has restructured the Bronx District Attorney's Office to reflect 21st Century prosecution, focusing on assistance for victims, fairness to defendants, crime prevention and community outreach. She created a Conviction Integrity Bureau, a Public Integrity Bureau, established a Rikers Island Prosecution Bureau to decrease violence and corruption in the jails, and enhanced services for victims of domestic violence, sexual assault and child abuse.

District Attorney Clark pioneered alternative to incarceration initiatives such as Bronx Community Justice, which involves "circles" of community volunteers who resolve petty crimes with offenders outside of the criminal justice system.

Prior to her election, District Attorney Clark served as an Associate Justice for the NYS Supreme Court Appellate Division, First Department; a NYS Supreme Court Justice in Bronx County; and a Criminal Court Judge in Bronx and New York Counties. She spent more than 16 years on the bench.

District Attorney Clark is a lifelong Bronx, New York resident, raised in public housing and educated in public schools. She received her Bachelor's Degree in Political Science from Boston College, where she serves as a member of the Board of Trustees, and earned her law degree at the Howard University School of Law in Washington, D.C.

District Attorney Clark returned home in 1986 to begin her legal career at the Bronx District Attorney's Office. She prosecuted drug felonies, violent crimes and homicides. District Attorney Clark served as a Supervising ADA in the Narcotics Bureau and the Deputy Chief of the Criminal Court Bureau. In 1999, she left the Office for her first judicial post.

District Attorney Clark is co-chair of Prosecutors Against Gun Violence, and a Board Member of both the National District Attorneys Association and the District Attorneys Association of the State of New York. She frequently addresses national and local legal organizations, including the American Bar Association, the National Black Prosecutors Association and the New York State and New York City Bar Associations, on a range of criminal justice topics.

District Attorney Michael Dougherty 20th Judicial District (Boulder County), CO



In 2018, Michael Dougherty became the District Attorney for the 20th Judicial District. In November of 2020, Michael had the honor of being re-elected. The District Attorney's Office is committed to enhancing community safety and improving the justice system.

Michael attended Nassau Community College and, then, went on to graduate from Cornell University and Boston University School of Law.

After law school, Michael served for twelve years as a prosecutor at the Manhattan District Attorney's Office. He started in the Trial Division and quickly rose to supervisory positions, including Deputy Chief of the Sex Crimes Unit. Later, he was promoted to the Executive Staff and became responsible for assisting with the management, budget, and personnel of the District Attorney's

Office, while continuing to prosecute serious cases. In 2009, Michael was recruited to head up the Colorado DNA Justice Review Project, an effort that helped lead to the exoneration of an innocent man wrongly convicted of murder. Just months after arriving in Boulder, Michael was promoted to serve as the head of the Criminal Justice Section for the Attorney General. In 2013, Michael became the second-in -command for the District Attorney's Office for Jefferson and Gilpin Counties.

Michael has served on numerous groups leading to significant criminal justice reform. Notably, Michael received the Innocence Project's Award for Advocate for Innocence and Justice. Additionally, Michael has helped establish problem-solving courts and diversion programs.

Michael currently serves as the co-Chair of Colorado's Sentencing Reform Task Force. He is, also, on the School Safety Resource Center Advisory Board. Since 2018, the DA's Office has launched innovative programs, such as the Bias and Hate Crimes Initiative, the Fresh Start Warrant Forgiveness Program, the Mental Health Diversion Program and the Conviction Integrity Unit. In addition, the Center for Prevention and Restorative Justice has been expanded significantly, with new diversion programs now in place.

Michael and his wife, Antonia, have been married for seventeen years, and are the proud parents of thirteen-year-old twins. Michael has twice finished the Leadville 100-Mile Trail Run (2013 and 2016), as well as 50-mile races around the state.

District Attorney Joyce Dudley

Santa Barbara County, CA



Joyce E. Dudley has a BA in psychology, and two Master's Degrees in Education; one with an emphasis on Early Childhood Education and the other with an emphasis on Educational Administration. In 1990, Joyce received her JD degree. The day she passed the Bar, she was hired by the Santa Barbara County District Attorney's office. For 20 years Joyce was a Deputy District Attorney specializing in prosecuting violent crimes against vulnerable victims. In 2010, she was elected District Attorney.

In 2016, she was appointed by Governor Brown to be the Chair of the Police Officers Standards and Training Commission (POST), a position she still retains. Joyce also presently serves on the Executive Board of Fight Crime Invest in Kids and is the National Co-Chair of Prosecutors Against Gun Violence.

Joyce has received numerous awards including: Woman of the Year

(Democratic Women) 2021, Attorney of the Year (Santa Barbara Women Lawyers), Woman of the Year (Junior League), and Mentor of the Year (Council on Alcohol and Drug Abuse).



District Attorney John Flynn

Erie County, NY



John J. Flynn is currently the 41st District Attorney of Erie County, NY.

Flynn, born and raised in Western New York, attended Bowling Green State University, in Bowling Green, Ohio, and graduated with a Bachelor of Arts degree in 1988. Flynn joined the United States Navy after college. He attended Naval Officer Candidate School, in Newport, Rhode Island, and upon graduation, he was commissioned an Ensign in the United States Navy. He then attended Navy Supply Corps School (The Navy's Business School), in Athens, Georgia, and upon graduation was assigned to the USS

CLEVELAND (LPD-7), stationed in San Diego, California. There he served as the Assistant Supply Officer deploying overseas to the Western Pacific and served during the Gulf War.

After he fulfilled his naval commitment, Flynn returned to his hometown of Buffalo, NY and attended The University of Buffalo School of Law. While in law school he continued to serve in the Naval Reserves. Upon graduation from law school in 1995, he went back on active duty and served in the Navy Judge Advocate General's (JAG) Corps. He served as a Navy attorney at Pensacola Naval Air Station, in Pensacola, Florida, where he was also appointed a Special Assistant United States Attorney, then served his final two years on active duty at the United States Naval Academy, in Annapolis, Maryland. Flynn was awarded the Navy and Marine Corps Achievement Medal and two Navy and Marine Corps Commendation Medals during his time on active duty.

In 2001, Flynn left active duty and again returned home to Western New York. He joined the Erie County District Attorney's Office as an Assistant District Attorney. He was quickly promoted to the Homicide Bureau, where he served until leaving in 2002 to enter private law practice. Flynn was a civil defense attorney and plaintiff's attorney from 2002 to 2016. He also served as a lecturer at SUNY Buffalo State from 2009 to 2016, teaching a Moot Court class in the Political Science Department. Flynn continued to serve in the Naval Reserves until his retirement in 2017. After re-affiliating with the reserves in 2001, he earned four additional Navy and Marine Corps Commendation Medals.

In 2003, Flynn decided to make his first run for public office. He ran for and won a seat on the Town of Tonawanda Town Board. In December of 2006, Flynn was appointed Town Justice in the Town of Tonawanda. He won election to a full term in 2007. In 2008, Flynn was appointed an acting Buffalo City Court Judge. In 2010, Flynn left the bench and was appointed Town Attorney in Tonawanda, NY. In 2016, he ran for Erie County District Attorney and took office on January 1, 2017.

Flynn resides in Tonawanda, NY with his wife, Debra, and has five children.

Deputy Director of Legal Training Linda Ford


New York County, NY



Linda Ford is the Deputy Director of Legal Training at the New York County District Attorney's Office where she has served as an Assistant District Attorney since 1988. Prior to her current role, she was a Senior Trial Counsel in the Trial Division where she was the lead prosecutor on more than 80 trials including trials for homicide, arson, kidnapping, conspiracy, robbery, burglary, assault, narcotics trafficking, firearms trafficking, and financial crimes. As a homicide prosecutor she responded to crime scenes and precincts on a 24-hour basis to supervise police investigations of homicides, non-fatal shootings and stabbings, suspicious deaths, vehicular fatalities, crimes at sensitive locations, and police involved shootings. Linda Ford delivers training programs on a wide range of topics including Investigating Violent Crime, Witness Protection, Science-Based Interviewing, Homicide Call, Search Warrant Practice, Confidential Informants, and Wildlife Trafficking.

Linda Ford serves on the Editorial Board of the International Investigative Interviewing Research Group Journal. She is a 1988 graduate of Georgetown University Law Center. Prior to attending law school, she worked for the Environment Liaison Center in Nairobi, Kenya, and studied International Development, Criminal Justice, and Music at Clark University.



Managing Director Betsy Fox-Tolentino


Roca Impact Institute, MD



A graduate of Southern Oregon University and Widener University School of Law, Tolentino's career has focused extensively on criminal and juvenile justice advocacy, and policy development aimed improving and building systems to meet the diverse needs of our communities. Tolentino's experience includes representing and advocating for criminal defendants and children in Maryland's foster care and juvenile justice systems, before trial courts, the Maryland General Assembly, and system stakeholders.

Betsy most recently served as the Maryland Department of Juvenile Services' Deputy Secretary of Community Operations where she focused on: changing the way young people, families, and stakeholders experience justice system interventions; mitigating racial disparities and developing a fair and equitable approach to reform; and empowering opportunities for shared innovation with partners to become a catalyst for change. In

addition to her current role as a Managing Director of the Roca Impact Institute, Betsy volunteers with community based organizations, serves on the Mentor MD/DC Board of Directors, and is an adjunct professor at the University of Maryland Baltimore County.



State's Attorney Kimberly Foxx

Cook County, IL



Kimberly M. Foxx is the first African American woman to lead the Cook County State's Attorney's Office – the second largest prosecutor's office in the country. Kim took office on December 1, 2016 with a vision for transforming the Cook County State's Attorney's Office into a fairer, more forwardthinking agency focused on rebuilding the public trust, promoting transparency, and being proactive in making all communities safe. She was elected for a second term in 2020.

As Cook County State's Attorney, Kim has undertaken substantial criminal justice reforms focused on public safety and equity. She has revamped the office's Conviction Integrity Unit, resulting in overturned convictions in over 175 cases,

including the first-ever mass exoneration in Cook County for 15 men whose convictions stemmed from misconduct by a Chicago Police Officer. She has been a leader in bond reform, instructing prosecutors to agree to recognizance bonds where appropriate, and reviewing bond decisions in cases where people are detained because they are unable to pay bonds of \$1,000 or less. Kim has taken the lead on prioritizing resources away from low-level offenses to focus on violent crime, including raising the threshold for approving felony charges for retail theft to \$1,000, and declining to prosecute misdemeanor traffic offenses for failure to pay tickets and fines. Kim played a vital role in passing legislation to legalize cannabis and provide the broadest and most equitable conviction relief possible. Providing this relief is not only a critical part of righting the wrongs of the failed war on drugs that disproportionately harmed communities of color; it is also a statement of her values and commitment to justice for all.

Kim is the first and only prosecutor in the country to make felony case-level data available to the public. The open data portal provides unprecedented access and transparency into the work of a prosecutor's office. Her goal is to make the Cook County the most transparent prosecutor's office in the country.

Kim served as an Assistant State's Attorney for 12 years, and was also a guardian ad litem, where she worked as an attorney advocating for children navigating the child welfare system. Prior to being elected State's Attorney, Kim served as Chief of Staff for the Cook County Board President, where she was the lead architect of the county's criminal justice reform agenda to address racial disparities in the criminal and juvenile justice systems.

Born and raised in Cabrini Green on Chicago's Near North Side, Kim is a graduate of Southern Illinois University, where she earned a B.A. in Political Science and a J.D. from the SIU School of Law.

District Attorney Sim Gill

Salt Lake County, UT



Sim Gill was elected as Salt Lake County District Attorney in November 2010. As a veteran prosecutor, Sim has been a champion on issues of therapeutic justice, criminal prosecution and alternatives to prosecution. He has long been an advocate of taking a systems approach to the issues of criminal and social justice, focusing on collaborative and community oriented approaches to problem solving.

Sim has collaborated on the creation and implementation of various therapeutic justice programs including Mental Health Court, Veterans Court, Salt Lake City Domestic Violence Court, Misdemeanor Drug Court and the Salt Lake Area Family Justice

Center. These alternatives seek to transition those offenders out of the criminal justice system who can most benefit from other programs—giving them a much greater chance to not re-offend.

Most recently Sim has been part of a collaborative effort to address the homeless population and drug trafficking in the Rio Grande area. This has been done by holding the criminals accountable and seeking treatment before jail for those who need it.

Sim graduated from the University of Utah with a B.A. degree in History and Philosophy. He received his J. D. degree and certificate of specialization in Environmental and Natural Resources Law from Northwestern School of Law at Lewis and Clark College in Portland, Oregon.

District Attorney Eric Gonzalez

Kings County, NY



Eric Gonzalez made history in 2017 when he became the first Latino elected District Attorney in the state of New York. He has spent his entire legal career in the Brooklyn DA's office, beginning in 1995 as an Assistant District Attorney in the Sex Crimes and Special Victims Bureau. DA Gonzalez worked his way up in the office, ultimately being named Chief Assistant District Attorney by his predecessor, the late Ken Thompson.

Following DA Thompson's untimely and tragic death in 2016, DA Gonzalez was appointed by Governor Andrew Cuomo as Acting District Attorney. Following his own election in 2017, DA Gonzalez launched a groundbreaking initiative known as Justice 2020, to help him

carry out his vision of keeping Brooklyn safe and strengthening trust in our justice system by ensuring fairness and equal justice for all.


Justice 2020 consists of a 17-point action plan – created by a committee of criminal justice reform experts, advocates, defense groups, service providers, law enforcement, formerly incarcerated individuals, clergy and community leaders – to make the Brooklyn District Attorney's Office a national model of progressive prosecution. This blueprint is transforming the work of DA Gonzalez's office by shifting toward preventative and accountability solutions based in communities, and away from over -reliance on criminal convictions and incarceration.

DA Gonzalez grew up in East New York and Williamsburg, Brooklyn, and attended John Dewey High School in Coney Island. He graduated from Cornell University in 1992 with a Bachelor of Arts degree with a dual major in government and history. In 1995, he received his Juris Doctorate from the University of Michigan Law School, where he was president of the Latino Law Students Association.



Executive Director Teny Gross

Institute for Nonviolence Chicago, IL



A veteran of the Israeli Defense Force and of trying to build peace between Palestinians and Israelis, Teny began his career in ending violence as a senior street worker for the city of Boston. He was later recruited for the position of CEO at the Nonviolence Institute in Providence, RI. Teny has a BFA from Tufts, an MTS from Harvard, and a fellowship in Strategic Perspectives in Nonprofit Management from Harvard Business School .





Deputy Chief Jackie Gwinn-Villaroel received her MS in Public Safety Administration at Columbus State University; currently she is the Deputy Chief of the Louisville Metro Police Department where she serves as the second of command of the department and functions as Chief of Staff. Deputy Chief Gwinn-Villaroel is a 25- year law enforcement veteran and accomplished police executive. Before coming to Louisville, Deputy Chief Gwinn-Villaroel was a major with the Atlanta Police Department and has worked a broad range of assignments, including plainclothes work (narcotics and vice), Gangs and Guns, Domestic Violence Investigations, Commander of the Crime Tactical Analysis Unit and Patrol; served as the Assisted Commander of the Major Crimes Section which housed the following units: Homicide, Robbery, Gun Assault, Special Victims Unit (Sex Crimes), and the Atlanta Police Crime Stoppers Unit. Her last assignment with the Atlanta Police Department was the major of the Training Academy. She is affiliated with numerous professional organizations, including the National Organization of Black Law Enforcement Executives, the International Association of Chiefs of Police, National Association of Woman Law Enforcement Executives, Major Cities Chiefs Association, Police Executive Research Forum, IACP

Women's Leadership Institute Alumni, Kentucky Association Chiefs of Police, and a graduate of the Major Cities Chiefs Police Executive Leadership Institute.



Executive Director Kristine Hamann Prosecutors' Center for Excellence



Kristine Hamann is the Executive Director and founder of Prosecutors' Center for Excellence (PCE). PCE provides policy expertise for modern prosecutors. PCE's consulting and research services promote best practices, spur innovations and implement solutions. PCE also supports statewide prosecutor-led Best Practices Committees that have formed in 20 states. PCE publishes articles and produces the Articles of Interest Series and the Did You Know Series on a wide variety of issues related to prosecutors. PCE hosts regular national meetings for prosecutors to share ideas on best practices and emerging issues.

From 2013 to 2016, Kristine Hamann was a Visiting Fellow at the Department of Justice/Bureau of Justice Assistance. She is the chair of the New York State Best Practices Committee for prosecutors and she is an advisor of the National District Attorneys Association's Best Practices Committee. She is an Adjunct Professor at Georgetown Law School. She is a member of the ABA Criminal Justice Council and is on the ABA Criminal Justice Journal Editorial Board. She was an Independent Counsel to the Conviction Integrity Unit of the United States Attorney's Office for the District of Columbia.

From 2008 to 2013, Ms. Hamann was the Executive Assistant District Attorney for the Special Narcotics Prosecutor for the City of New York. The office conducts international, national and local drug trafficking investigations and prosecutions which impact New York City.

From 2007 to 2008, Ms. Hamann was the New York State Inspector General. The Inspector General is charged with investigating and preventing fraud, waste and abuse in New York State government.

From 1998 to 2007, Ms. Hamann served as the Executive Assistant District Attorney to D.A. Robert M. Morgenthau in the Manhattan District Attorney's Office in New York City. Prior to 1998, Ms. Hamann held several other positions in the Manhattan District Attorney's Office, including Deputy Chief of the Trial Division in charge of the Criminal Court, Director of Training, and Deputy Bureau Chief of the Career Criminal Bureau. After law school she was an associate at Simpson Thacher and Bartlett in New York City.

She has received various awards including the Ethics and Accountability Award (City & State NY, 2018); Outstanding Prosecutor of the Year (NY State Bar Association, 2013), Prosecutor of the Year for Executive Leadership (NY District Attorneys Association, 2010), Excellence in Government Award (Albany Law School, 2008), Public Service Award (NY County Bar Association, 2005) and New York County District Attorney's Office Prosecutor of the Year (2001).

District Attorney Hillar Moore, III Parish of East Baton Rouge, LA



District Attorney Hillar C. Moore, III, serves East Baton Rouge and the 19th Judicial Court from a people-first position that prioritizes public safety while modernizing prosecution practices for the welfare of everyone involved in criminal justice investigations. Drawing on over 40 years of experience with the legal system, Hillar Moore values collaboration at all levels to prevent crime, enhance public safety, and strengthen community infrastructure. Evidenced by his presence at every crime scene and open invitation to meet with citizens to hear their concerns, Hillar's tireless work ethic and compassion for survivors guide his actions as a prosecutor, victim's advocate, and public servant.

Since taking office in 2009, Hillar has confronted complex, deeply rooted threats to children, women, and families, including domestic violence, sexual assault, and opioid addiction. Under his leadership, the DA's Office spearheads several ongoing initiatives like <u>Stop the Loss</u> and <u>TRUCE</u>, which employ innovative and non-traditional methods to identify abusers, reduce violence, and save lives. When faced with a steep rise in homicide and opioid-related deaths, Hillar <u>successfully secured grant funding</u> to help law enforcement officers to conduct more thorough investigations, gather covert intelligence, and collect and report uniform data of drug related violent crime, thereby enabling them to build more substantial and effective cases against drug dealers. He continuously fosters inter-agency collaboration and cultivates the necessary cross-sector partnerships with community stakeholders at all levels to identify issues plaguing the community and to respond with innovative and effective solutions. As such, Hillar has transformed the Office's conventional role in the community and expanded its impact beyond prosecution in the courtroom to encompass numerous sustained investments in the community it serves.

While in private practice, Hillar recognized that expungement could significantly improve citizens' employment prospects and their family's future for those citizens who carry a criminal record. Staffed by volunteers from the DA's Office and other local agencies, the <u>Baton Rouge Easy Expungement</u> <u>Screening</u> (BREES) program aims to streamline the often arduous and expensive process.

Following the tragic loss in 2017 of Max Gruver, who died while pledging at the Louisiana State University chapter of Phi Delta Theta, Hillar sought to clarify legislation surrounding the prosecution of hazing, leading to the <u>Max Gruver Act</u>. The act created a felony hazing charge if a victim dies or is seriously injured and instituted state-wide hazing definitions, penalties, and prevention education. Under the previous law, hazing was considered a misdemeanor and was outlined in one sentence. Hazing is now considered a felony if a victim dies or is seriously injured.

Now in his third term, Hillar Moore leads one of the most diverse offices in the nation. Firmly woven into the fabric of East Baton Rouge, Hillar regularly volunteers with the: Susan G. Komen Race for the Cure, Baton Rouge Children's Advocacy Center's Celebrity Waiter, Junior League of Baton Rouge's Touch-a-Truck, Toys for Tots, NAACP, Sexual Trauma Awareness & Response, St. Vincent De Paul's Turkey Carving Contest, 100 Black Men of Baton Rouge, and many others. Hillar Moore's consistent and vigorous action demonstrates that he is more interested in building community than building cases.

Chief Deputy Prosecutor of the Juvenile Division Jimmy Hung

King County, WA



Jimmy Hung is the Chief Deputy Prosecutor of the Juvenile Division of the King County Prosecuting Attorney's Office in Washington State. He graduated from the University of Washington School of Law in 1999 and joined the office that year. During his time as a prosecutor he has worked on all levels of felony and misdemeanor trial practice including homicide, sexual assault, and domestic violence. Jimmy has led efforts in King County to reduce the use of secure detention and formal court processing of youthful offenders, while increasing the use of restorative justice options. In December of 2018, Governor Jay Inslee appointed Jimmy to the Washington State Partnership

Council on Juvenile Justice where he serves as Co-Chair of the Race and Ethnic Disparities Committee. Jimmy has previously served on the boards of the Asian Bar Association of Washington and the Washington State Bar Association's Criminal Law Section Executive Committee where he was once President. Jimmy also serves as a board member of Choose 180, and Sound Discipline, two local nonprofits that aim to support young people and seek an end to the school-to-prison-pipeline. Chief Diversity Officer and Chief of Gang Prosecutions Nigel Farinha Office of Special Narcotics, NY



Nigel I. Farinha is currently the Chief of Gang Prosecutions for the Special Narcotics Prosecutor of the City of New York. He is also the Chief Diversity Officer for this agency, and a member of the Citywide Diversity Thought Leaders Working Group.

Mr. Farinha has been a New York County Assistant District Attorney for over twenty-five years. He is one of the founding members of the Narcotics Gang Unit, which is responsible for the prosecution of organized, violent street crime within the five boroughs of New York City. In the relatively short time that his unit has been in existence, Mr. Farinha has received several awards including the 2017 New York City Bar Association's Thomas E. Dewey Medal Award for Outstanding Contributions to the Office of the District Attorney, The International Narcotic Enforcement Officer's Annual Award of Honor, The Drug Enforcement

Administration Certificate of Appreciation Award for Outstanding Contributions in the Field of Drug Enforcement, The Office of Special Narcotics Annual Achievement Award for the Outstanding Assistant District Attorney of the Year, The St. Paul's Church Achievement Award for Outstanding Public Servant of the Year and The Hamilton Heights Block Association Annual Award for Outstanding Community Contribution.

In 2003 Mr. Farinha was promoted to the rank of Senior Trial Counsel, and in that capacity, he prosecuted several high profile cases including the trial of the "Nine Trey Gangsters" reportedly the very first Bloods Gang Sect to organize in New York City, and also the "Untouchables" a notorious "push-in" robbery crew. In 2007 he was promoted to the position of Deputy Chief of his division before assuming his current role of Chief of Gang Prosecutions in 2011. In 2016, Mr. Farinha served as lead trial counsel in two murder trials involving the Crips Gang Sect controlled by Epic Records rapper "Bobby Shmurda" resulting in lengthy prison sentences for the most violent members of his crew.

Mr. Farinha has given several lectures on gang enforcement including to The Deputy Commissioner's Office of the NYPD, The National College of District Attorneys, The New York County Lawyers Association, The MAGLOCLEN Annual Violent Gang Conference, Kansas State Bar Association, The National Hispanic Prosecutors Association, and The National Black Prosecutors Association. He has served as a Faculty Assistant during the National College of District Attorney's Annual Career Prosecutor course in Charleston, South Carolina. He has also been a Trial Advisor for the District Attorney of New York's Trial Advocacy program for new Assistant District Attorneys, for over nine years.

He is a frequent lecturer on search warrant practice at the Port Authority Police Department, and a guest lecturer on ethical legal practice at York College.

He is the Past President and Executive Board member of the Local Chapter of the National Black Prosecutors Association. He serves on the Executive Committee of the Criminal Justice Section of the New York State Bar Association. He is a member of the District Attorney of New York (DANY) Permanent Hiring Board, a founding member of the DANY Diversity Outreach Committee, a certified New York City EEOC counselor, a Program Director and Senior Advisor for the Justice Ambassador's Youth Council, a Board Member and Chairman of the Global Leadership and Achievement Foundation, and an active member of The Jersey City Alumni Chapter of Kappa Alpha Psi Fraternity, Inc.

He is a graduate of Brown University and New York University School of Law.

Denise O'Donnell is President of Leadership for Justice Innovation LLC, a criminal justice consulting firm. She served as a Distinguished Senior Fellow at the Marron Institute of Urban Management at New York University from 2017-2019. She is currently Project Director of The Osborne Association's Safeguarding Children of Arrested Parents Project with the Buffalo Police Department funded as part of the WNY Covid-19 Community Response Fund. Ms. O'Donnell has over twenty years of experience with the United States Department of Justice. After graduating from law school, she joined the United States Attorney's Office in Western New York as an Assistant United States Attorney. From 1997- 2001 she served as presidentially appointed United States Attorney. She returned to DOJ in 2011 as Director of the Bureau of Justice Assistance. At BJA, her accomplishments include launching BJA's "Smart Suite" of eight

criminal justice grant programs that implement research-practitioner partnerships to advance the knowledge of what works in policing, prosecution, defense, community corrections, pre-trial, re-entry, opioid use disorders, and building strong communities. She serves on a number of Boards and Advisory Groups including The Prosecutors' Center for Excellence, George Mason University Center for Evidence-Based Policing, and the Western New York Reentry Coalition, and is a member of the New York State and Erie County Bar Associations.



County Prosecutor Jean Peters Baker

Jackson County, MO



Jean Peters Baker has spent more than two decades in the prosecutor's office, serving in nearly every unit of the office. She was appointed Jackson County Prosecutor in May 2011, only the second woman to lead the office; the first, former-U.S. Sen. Claire McCaskill, hired Jean as a young assistant prosecutor. Baker is known as a prosecutor unafraid of tackling difficult cases. In 2011, she prosecuted the bishop of the Diocese of Kansas City-St. Joseph for failing to report potential abuse of children by a priest. She was later named special prosecutor in a high-profile sexual assault involving high school football players in northwest Missouri. Recently, Baker successfully pursued the release of Kevin Strickland, who was wrongly convicted and served 43 years in a Missouri prison. During her decade as Jackson County's top prosecutor, Baker has made gun violence a strong focus, including the development of innovative ways to reduce it.



County Prosecutor Dan Satterberg

King County, WA



Dan Satterberg has served in the King County Prosecuting Attorney's Office for more than three decades, and was first elected to lead the office in November 2007. He served as Chief of Staff to Norm Maleng for 17 years, and was responsible for the management and operation of the PAO. The KCPAO has 240 attorneys, and a total staff of more than 500.

King County has more than 2.1 million residents, making it the 13th largest county in the United States.

Dan is committed to improving public safety and the reform of the Criminal Justice system through partnership with the communities most impacted by crime. Together with community

partners, Dan has created successful programs to keep young people engaged in school and divert youth from the courtroom to more effective and impactful accountability programs led by credible messengers to change the way young people think and act.

The KCPAO is a founding partner in the creation of LEAD (Law Enforcement Assisted Diversion), a national model creating a compassionate response to drug-addicted people, and giving police additional tools for responding to people with addiction and mental health issues. Further work is being done to expand this concept in King County, and to identify and assist frequent utilizers of the jail before their next arrest.

Dan also believes that we need to do more to help people leaving prison make a successful transition, and he is committed to reducing recidivism among people leaving jail and prison as the best strategy to improve public safety and reduce the costs of incarceration. He is the co-chair of the Washington State Reentry Council, and also a member of the Washington State Criminal Justice Training Commission.

Dan was born and raised in South King County and attended Highline High School. His father was a lawyer in White Center and his mother was a nursing instructor at Highline Community College. He graduated from the UW undergraduate school (Political Science and Journalism) and the UW Law School. He has two adult children and has been married for more than 30 years. He also plays bass and sings in the classic rock cover band, "The Approximations."


Professor Patrick Sharkey

Sociology and Public Affairs, Princeton University



Patrick Sharkey is Professor of Sociology and Public Affairs at Princeton University. He received his Ph.D. in Sociology and Social Policy from Harvard. Sharkey was formerly Chair of Sociology at New York University, served as Scientific Director at Crime Lab, New York, and is the founder of <u>AmericanViolence.org</u>.

Two of his publications include: *Uneasy Peace: The Great Crime Decline, the Renewal of City Life,* and the *Next War on Violence* (2018), and Stuck in Place: Urban Neighborhoods and the End of *Progress toward Racial Equality* (2013).



Executive Director Ben Struhl

Crime and Justice Policy Lab, University of Pennsylvania



Ben Struhl is the Executive Director of the Crime and Justice Policy Lab (CJP) at the University of Pennsylvania. In that role, he works with governments and non-profits around the world to promote the use of research evidence in solving health and safety challenges that are facing disadvantaged communities. CJP forms a bridge between science and implementation, with a focus on preventing crime and violence, reforming the criminal justice system, and collaborating with communities to ensure that policy is done in ways that respect and uplift constituents.

At CJP, Struhl oversees the strategy and operations of projects ranging from violence prevention to prosecutorial reform to tracking the sale of illegal guns in the US. Struhl manages major projects in cities including Philadelphia, Baltimore, Boston, Oakland, and San Francisco, and engages in national and international policy work with partners such as ATF and USAID.

One significant CJP project that Struhl collaborates on is the lab's innovative partnership with the Philadelphia District Attorney's Office (DAO) to conduct research on the role of prosecutor-driven policies in improving fairness and efficiency in the criminal justice system. The research team supports an overhaul of the DAO's data infrastructure, conducts studies, and applies computational models to promote diversion and better services. Struhl has also worked with several other prosecutor's offices across the US.

Prior to his work at Penn, Struhl launched and was Executive Director of the Center on Crime and Community Resilience at Northeastern University, leading projects in seven US cities and ten countries across the Caribbean and South America. Before Northeastern, Struhl worked at MIT's Poverty Action Lab (J-PAL) where he launched and managed the organization's new division on crime research, as well as serving as the policy lead on J-PAL's new North America office.

Struhl has also worked for the Mayor of Boston, Boston Public Schools, the Center for American Progress, and as a data analyst for Senator and then President Barack Obama. He has an M.P.P. from Georgetown University, and a B.A. from Brown University.

Managing Director of Community Violence Initiatives James Timpson

Roca Impact Institute, MD



James (JT) Timpson serves the Managing Director of Community Violence Initiatives for the Roca Impact Institute. His extensive expertise and leadership in violence intervention initiatives spans over two decades. JT was a founding Director of Roca's expansion to Baltimore where he helped grow Roca to employ over 30 full-time staff serving young men ages 16-24 that are most likely to shoot or be shot. As a Senior Advisor with the Roca Impact Institute, JT serves as a subject matter expert on building community partnerships, safety and risk mitigation, hiring the right people for the right roles, understanding brain science, trauma, and behavior change interventions, and the implementation of the kind of relentless outreach and relationship building that defines Roca's model.

Prior to Roca, he served as Liaison Officer for Safe Streets, Baltimore's Cure Violence replication, and was responsible for providing oversight and technical assistance to the directors of five community outreach sites. He also served as the Site Director for Safe Streets Park Heights in

Baltimore. While Director, JT led a staff of six Outreach Workers/Violence Interrupters in preventing and reducing homicides in Baltimore's Northwest District. Before joining Safe Streets, JT worked in the Mayor's Office in Baltimore City for over 12 years in different capacities, including Assistant Director of The Mayor's Office of Employment Development's Re-Entry Center and leading the implementation of crime reduction initiatives in the Mayor's Office on Criminal Justice including Operation PROTECT, a crime reduction strategy aimed at Baltimore's most violent neighborhoods, and Project Exile, a targeted enforcement strategy directed at felons who carry guns.

JT's passion and expertise extend well beyond his work at Roca. He currently serves as a committee member for the Baltimore Mayor's Cabinet for Boys and Young Men of Color, and previously participated on Mayor Scott's Public Safety Transition Team. JT also serves as an advisor on both the Johns Hopkins Innovation Fund, and the Accountability Board Selection Committee for Johns Hopkins University. He is a two-time panelist on gun violence for the Amnesty International Annual General Meeting. In 2021 he was awarded Hometown Hero for Gun Violence by Amnesty International.

Commonwealth Attorney Tom Wine

Jefferson County, KY



Thomas B. Wine was elected as the Commonwealth's Attorney for the 30th Judicial Circuit in November 2012. His six year term of office began on January 1, 2013. He was reelected in 2019 for his second six year term.

Prior to being elected Commonwealth's Attorney, Tom enjoyed serving in the Justice system as both a prosecutor and a judge. He was sworn in as Assistant Commonwealth's Attorney in Jefferson County, October 1980, under David L. Armstrong. In 1982 that office awarded him Prosecutor of the Year.

In 1984 he began work at the Kentucky Attorney General's Office. He served as chief of the Leviticus Unit, investigating fraudulent investments in coal and oil tax shelters; was an Assistant in the Special Prosecutions Unit; and served from 1986

until 1987 as the first Director of the Medicaid Fraud and Abuse Control Unit.

Tom returned to the Office of Commonwealth's Attorney in Jefferson County in January 1988 where he served as a Division Chief until December 1990.

Tom resigned as a prosecutor to run for Jefferson Circuit Court. He was elected in November 1991 and began his first year term on January 6, 1992. In 1997 the Louisville Bar Association recognized him as Judge of the Year. He was re-elected without opposition to serve a second term in 1999. The Jefferson Circuit Court term elected him as Chief Judge in 2000.

In September 2000, Chief Justice Joseph Lambert appointed Tom to serve on the Jefferson County Racial Fairness Commission. He continues to be a member of that Commission and has served on the subcommittees involving jury selection and setting bonds.

In August 2006, Governor Ernie Fletcher appointed Tom to the Kentucky Court of Appeals. He was elected to a full term in November 2006. He was appointed by Chief Justice Joseph Lambert to Chair the Kentucky Court of Justice Records Retention Task Force. Chief Justice John Minton of the Kentucky Supreme Court appointed Tom to serve as the first Chair of the Technology Governance Committee of the Kentucky Court of Justice as well as a member of the County Law Library Task Force.

In January 2012, Tom resigned from the bench to pursue the opportunity to serve as Jefferson County's top felony prosecutor. Tom has been a Master in the American Inns of Court, Louis D. Brandeis Inn and has served as the President of the Inn for 2 years. In 2009, he received the Fair Administration of Justice Award from the Kentucky Association Criminal Defense Lawyers.

Tom has volunteered in the Community for several years and in 1996 received the Community Service Award presented by Central Labor Council, AFL-CIO. He has volunteered with the Cub Scouts and Boy Scouts and in 2012 received the Silver Beaver Award, the highest award a Boy Scout Council can give to a volunteer. 41

District Attorney Kym Worthy

Wayne County, MI



Wayne County Prosecutor Kym L. Worthy received her undergraduate degree in economics and political science from the University of Michigan, and her law degree from the University of Notre Dame School of Law. In 1984, she began her legal career at the Wayne County Prosecutor's Office, and in 1989, she became the first African-American selected by the office as a Special Assignment Prosecutor. She specialized in high profile murder cases, including the prosecution of Toni Cato Riggs (convicted of the murder of her husband, a returning Gulf War Veteran) and of two Detroit Police Officers convicted in the beating death of motorist Malice Green.

In 1994, Worthy was elected to the Detroit Recorder's Court (now the Wayne County Circuit Court). During the next nine years, she presided over hundreds of serious felony cases and was re-elected to the court twice by overwhelming margins. As a judge, she served on numerous court committees and sat on the Board of Directors for the Wayne County Criminal Advocacy Program, which provides training and continuing legal education for felony trial attorneys. She was on the faculty of the Michigan Judicial Institute, which trains new judges, and was President of the Association of Black Judges of Michigan from 2001-2002. Worthy was also a Master of the Bench for the American Inns of Court, a member of the Wolverine Bar Association, and a member of the Michigan Judges Association. In the fall of 2007, the State Bar of Michigan conferred the prestigious Frank J. Kelley Distinguished Public Service Award upon Worthy, recognizing her many career achievements, including the many innovative programs and new units that she has created in her role as the Wayne County Prosecutor.

On January 6, 2004, Worthy came full circle in her career and returned to the Wayne County Prosecutor's Office, this time as the Wayne County Prosecutor, the first African American and the first female to hold the position. She had declared her candidacy for the office for the November 2004 election. These plans were accelerated when the incumbent resigned and she was appointed by a majority of the Wayne County Circuit Court Judges.

In 2008, Worthy charged and successfully prosecuted ex-Mayor of Detroit Kwame M. Kilpatrick and his former Chief of Staff Christine Beatty. The case garnered national and international press coverage. She has been widely acknowledged for her courage and integrity in charging a case that could have negatively impacted her political career. As a result of this case, Worthy has received the following awards and honors: Michigan Chronicle Women of Excellence Award; Southfield-Lathrup Optimist Club Public Servant of the Year; Detroit Free Press Renaissance Hero; Radio One Newsmaker of the Year; Channel 7 Spotlight on the News Newsmaker of the Year; Spirit of Detroit Award; Crain's Most Powerful Attorneys; MADD Outstanding Service Award; CLEO Legacy Public Service Award and Crain's Women to Watch Award.

Worthy has been a persistent advocate for witnesses who risk their lives to come to court and testify. Due to her tireless advocacy, the Wayne County Commission awarded funds solely to be used to protect witnesses. This important allotment continues today.

Worthy has used her prosecutorial experience to greatly enhance the Wayne County Prosecutor's Office. She created the first Elder Abuse Unit in the history of the office. This unit handles all cases involving elderly and vulnerable adults, and focuses on the unique needs of senior citizens when they are victims of crime.

Appalled by the degree of gun violence in Detroit, Worthy conceived and implemented a "Change the Culture" initiative that focuses on educational training and community policing in an effort to reduce gun violence. The first public forum, held on January 25, 2004 at Greater Grace Temple in Detroit, drew over 3,000 citizens, church and civic leaders.

Worthy has been an adjunct professor of criminal law at the University of Detroit/Mercy and has lectured at Harvard Law School, the University of Notre Dame Law School, Wayne State University Law School and the Universite des Sciences Sociales in Toulouse, France. She has lectured for the National College of District Attorneys, the Prosecuting Attorneys Association of Michigan, and the Detroit Police Department.

Worthy is working on resolving a massive backlog of unprocessed rape kits in Detroit. In 2009, one of her assistants discovered a large number of rape kits sitting in a warehouse that the Detroit Police Department used as an overflow storage facility for evidence. It was determined that 11,341 rape kits had been sitting in the warehouse, unprocessed, for a decade or more. She is currently featured in the HBO documentary I AM EVIDENCE, produced by Mariska Hargitay, that examines the rape kit crisis around the country.

Recognizing that "service is the rent we pay for living", Worthy is active in The United Way, The Sickle Cell Disease Association of America, The Lead Poisoning Task Force of Michigan, the Optimist Club, and the Delta Sigma Theta Sorority. She created the Alexandra Simone Fund for the Neonatal Intensive Care Unit of Henry Ford Hospital in memory of her deceased daughter. The fund provides services to the parents of prematurely born infants. An advocate for all children, she frequently speaks out about the need for fostering and adoption of children who do not have a permanent home. Worthy was named one of "America's Best and Brightest" by two nationally-circulated magazines, and has received over 100 other awards and honors for her public service and community leadership. She is a sought-after motivational speaker for youth, civic, and church organizations.



DOWNTOWN SALT LAKE MAP





Public transportation to and from the Salt Lake City International Airport is provided by the Utah Transit Authority (UTA).

The Green line begins at the Salt Lake International Airport, runs through downtown Salt Lake and the out to West Valley City. At the airport riders can board at the station and Welcome Center just outside terminal one. Fare is \$2.50 and trains run every 10-15 minutes. Weekday service runs from 5:30 am to 11:30 pm, with a more limited schedule on weekends.


