

### Non-Public-Safety Traffic Stop Changes in Ramsey County





#### RCAO Policy Announced September 8, 2021

Ramsey County Attorney will decline to prosecute cases stemming from:

- 1. "Non-public-safety" traffic stops, stops based solely on certain minor equipment or registration infractions with exception for danger to public safety or a dangerous condition; or
- 2. The result of searching a vehicle based solely on consent, without any articulable suspicion.



#### **Non-Public-Safety Traffic Stops**

#### **Minor Equipment Infractions**

- Vehicle registration
- License plate illumination
- Windshield prohibitions, such as cracked windshields or objects hanging from the rear-view mirror
- Window tint or other restrictions on glazed windows
- Headlights, signal lights or rear lamp violations, unless both headlights or rear brake lights are nonfunctioning



#### **Changed Policies or Practices**

- Roseville
- Ramsey County Attorney
- Saint Paul Police Department
- Maplewood Police Department
- St. Anthony Village Police Department









#### **Results**

- Non-public-safety traffic stops went down by 86%, and related searches declined by 92% for participating police departments.
- Non-public-safety traffic stops by participating departments decreased from 25% to 5% of all traffic stops.
- Black drivers in Ramsey County experienced the largest decrease in non-public-safety traffic stops per capita, down 66% the year after the change.
- The changes had no discernible effect on crime rates.





















Lights On! partners with law enforcement and auto service providers to replace traffic tickets with repair vouchers.







#### **Alternatives**

• Since January 12, 2023 Roseville has sent out over 1,925 letters and provided 60 Lights On vouchers.

 Since May 30, 2022 Saint Paul has sent out over 1,400 letters and provided 22 Lights On vouchers.

• In the first month, January 2024, Maplewood sent 126 letters and provided 16 Lights On vouchers.
