## Mission

Prosecutors Against Gun Violence (“PAGV”) is a non-partisan group of over 60 leading prosecutors who serve approximately 65 million individuals in more than 30 states focused on ending gun violence in all its forms. Since 2014, PAGV has been committed to reducing gun violence by identifying solutions and implementing strategies from promoting safe storage in the home, to preventing suicides and accidental shootings involving children, to combating illegal firearms trafficking, to preventing and prosecuting mass shootings. PAGV represents prosecutors who are playing a leading role in reclaiming their communities and combating the gun violence that threatens public health and safety.



# National Advocacy

## Amicus Briefs/Legislation

### 2022

- President Biden announces ATF Rule on Ghost Gun kits
- PAGV asks Visa and Mastercard to end use of their cards to purchase ghost gun parts online.
- PAGV files an Amicus Brief urging the U.S. Court of Appeals for the Eighth Circuit to oppose a North Dakota purchaser and seller of firearms an injunction against the ATF's ghost gun regulation in Morehouse Enterprises LLC v. ATF.
- PAGV joins in Amicus Brief urging the U.S. Court of Appeals for the Eighth Circuit to oppose a Texas firearm retailer an injunction against the ATF's ghost gun regulation in Division 80 LLC vs Garland.

### 2023

- PAGV files an Amicus Brief urging the U.S. Supreme Court to uphold a law that prohibits a person from possession of a firearm while under a domestic violence restraining order in United States v Rahimi.
- PAGV supports legislation requiring financial institutions and credit card companies to apply merchant category codes (MCCs) to classify firearm and ammunition transactions.

### 2024

- **PAGV joins with an Amicus Brief urging the U.S. Supreme Court to uphold ATF's ghost gun regulation in Garland v. VanDerStok.**

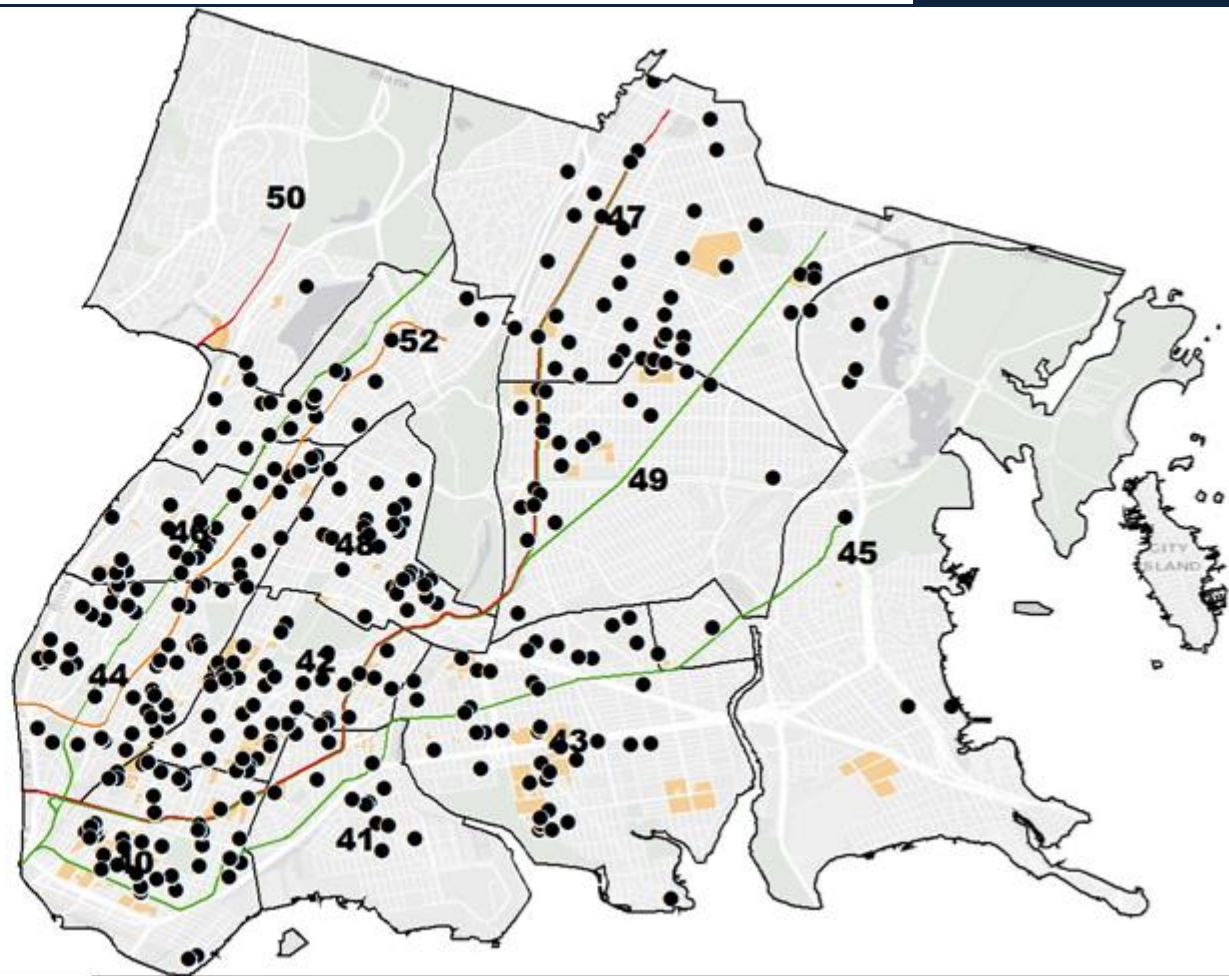
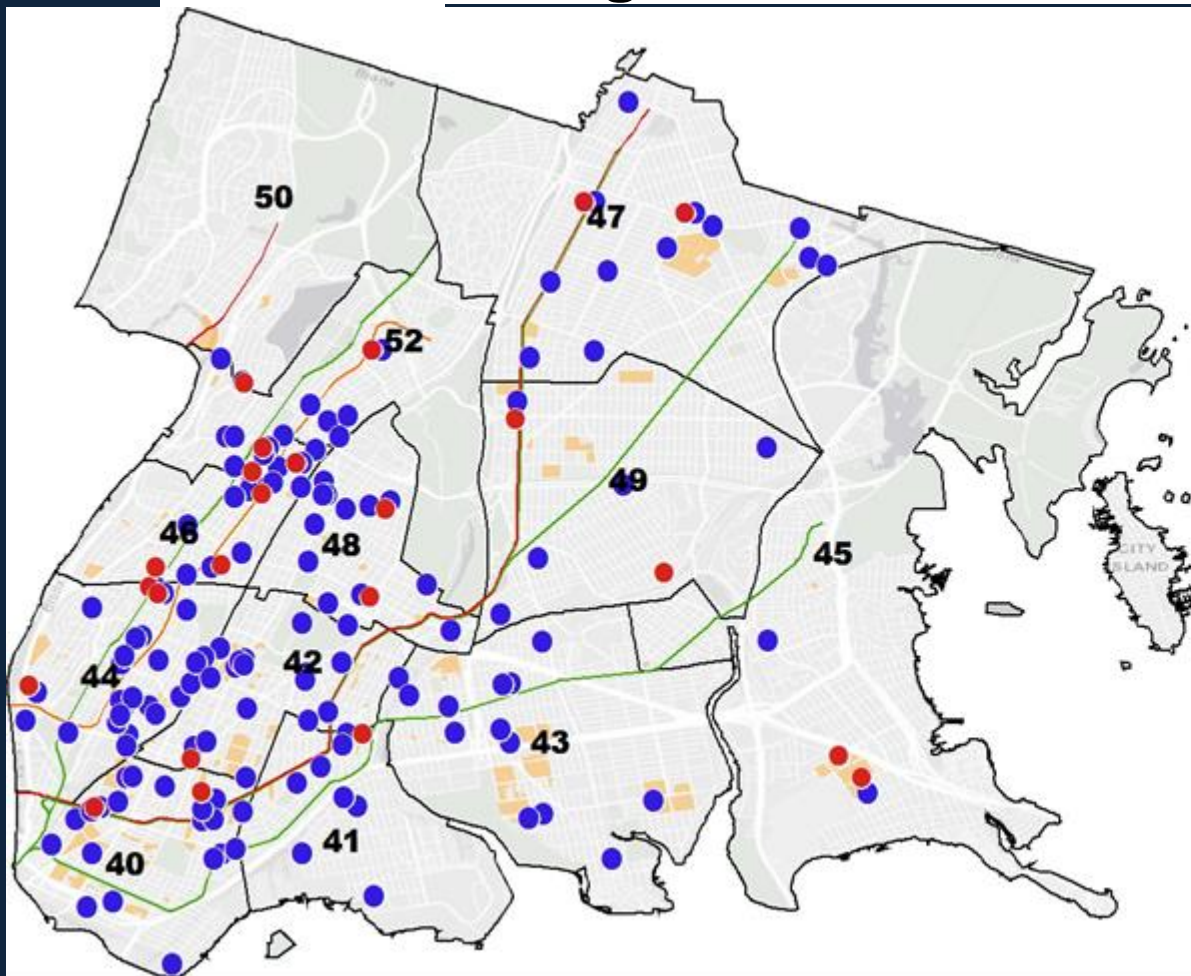
