FastPass

FastPass to Prosecution for Retailers is an innovative program allowing retail asset protection professionals to investigate and submit retail theft reports directly to the Yolo County District Attorney's Office.

This is in cooperation with local law enforcement and retailers.



FastPass Precepts

1. FastPass does not replace any aspect of law enforcement agencies, nor does it dictate to agencies how to do their job. FastPass is designed as another tool to use in combatting retail theft.

2. FastPass does not supersede any store policies regarding theft incidents. FastPass does not ask any employee to do anything outside of their policy or safety.



FastPass Model

Retailers write their own report of theft Reports and AV are uploaded via a secure portal The report is sent directly to the DA's office, and a copy to local LE

DA's office does any needed follow up and files the case



Two Paths to Success in Combatting Theft





FastPass Benefits to Retailers

- Asset Protection empowered to make a difference in their store
- Communication channels with other retailers opened
- Communication channels with law enforcement improved
- Theft reduction directly leads to improved customer experience and higher sales
- Deterrence word will spread not to steal
- Dispels the misconception that no one cares about retail theft



FastPass Benefits to Law Enforcement

- Law Enforcement resources are freed up
- More accurate incident reporting for NIBRS and funding
- Prosecutors get the big picture, not just a snapshot of Defendant
- More likely to disrupt catch and release cycle in the courts
- Defendants are held accountable in a timely manner with an appropriate course to reduce recidivism
- Overall theft reduction leads to improved community vibrance



How FastPass Works – Criteria

- Creating your own criteria that works for your jurisdiction.
 - What incidents do you want to focus on?
 - Which retailers are going to participate?
 - Which jurisdictions will participate?

Start small and scale up when ready.



Example of Yolo County Process – Criteria

The minimum threshold for the Yolo DA is cases involving any of:

- Theft over \$500
- Recidivism
- Conspiracy
- ORT
- Violence / Threats Against Staff
- Felony Level Crime



How FastPass Works – Dedicated Staff

- Prosecutors
- Investigators
- Crime Analysts
- Paralegal/ Clerical Staff
