# Speaker &





Danielle Alvarado Executive Director Working Washington & Fair Work Center

Danielle has more than a decade of experience working in movements for racial and economic justice across the country. As Executive Director, she provides leadership on organizational strategy, advocates for public policy that puts workers first, and fosters collaboration between our campaigns, legal, and education teams to build worker power in Washington state and beyond. She previously served as Legal Director, overseeing the Legal Clinic's efforts to recover \$1.5 million in stolen wages and expanding representation of low-wage workers in wage theft, harassment, and retaliation cases.

Before coming to Working Washington & Fair Work Center, Danielle was an Immigrants' Rights Staff Attorney at Takeroot Justice, where she provided direct representation, policy and technical assistance, and strategic campaign support to grassroots immigrants' rights organizations and worker centers in New York City. She serves on the Board of Directors for Detention Watch Network, a national organization dedicated to ending immigration detention in the United

States. She speaks Spanish, attended Whitman College and Northeastern University School of Law, and is a proud past recipient of the National Lawyers Guild C.B. King Award. Danielle is admitted to practice law in Washington and New York. When she's not working, Danielle enjoys taking her puppy out on walks and making pottery.



Richard Balletta Criminal Section Chief, Labor Bureau Nassau County, New York

Richard Balletta has been involved with Labor Law enforcement since 1998 when he joined the New York State Office of the Attorney General's Labor Bureau. For ten years Mr. Balletta concentrated on affirmative litigation to protect the rights of workers in New York State. While at the AG's Office from 1988 until 2008 he was a participating member of the New York State Joint Enforcement Task Force on Employee Misclassification, lead counsel on prevailing wage litigation, bankruptcy priorities litigation, and surety litigation. Mr. Balletta also helped to form and shape the direction the Labor Bureau's Criminal Prosecution Section which concentrated on felony prevailing wage and failure to pay wage prosecutions arising under the New York State Labor Law. In 2008, Mr. Balletta joined the New York State Department of Labor as the Assistant to the Executive Director of the New York State Joint Enforcement Task Force on Employee Misclassification and Chief Unemployment Fraud Officer. During that time he directed investigations for the member governmental agencies of the Task Force, coordinated settlements, administrative hearings, and criminal prosecutions related to the misclassification of workers and failure to pay Unemployment Insurance Contributions. In 2011, Mr. Balletta joined the Nassau County District Attorney's Office as the Chief of the Labor Unit where he directed criminal investigations and prosecutions involving prevailing wage law violations, minimum wage law violations, unemployment insurance fraud, workers' compensations fraud and tax fraud. In June of 2014 Mr. Balletta returned to the New York State Office of the Attorney General where he served as the Criminal Section Chief in the Labor Bureau. Longing for home, he retuned to the

Nassau County District two months ago where he is the Attorney-In-Charge of Labor.

Prior to entering Public Service in 1998, Mr. Balletta practiced criminal defense with the Nassau County Legal Aid Society and as a member of the law firm of Barket, Insardi & Balletta PC. Mr. Balletta is a graduate of Hamilton College and St. John's University School of Law.



#### Terri Gerstein

Director

NYU Wagner Labor Initiative, NYU Robert F. Wagner Graduate School of Public Service

Terri Gerstein is the Director of the newly-created <u>NYU Wagner Labor Initiative</u>, at New York University's Robert F. Wagner Graduate School of Public Service. The Labor Initiative is a hub of research and action to help government work more effectively for workers, focusing on both policy and implementation. Among other things, the Initiative focuses on expanding and improving state and local enforcement of worker protection laws, working extensively with state attorney general, district attorney, county attorney, and local labor standards offices, among others. Previously, Terri was the Director of the State and Local Enforcement Project at the Harvard Law School Center for Labor and a Just Economy; a Senior Fellow at the Economic Policy Institute; and an Open Society Foundations Leadership in Government Fellow.

Terri enforced labor laws for over 17 years in New York, including as Labor Bureau Chief in the New York State Attorney General's Office and as Deputy Commissioner in the New York State Department of Labor. In those roles, she implemented innovative approaches to enforcing workers' rights, including, among other things, industry-focused strategic enforcement, an increase in criminal prosecution, and extensive collaboration with worker organizations. Before her government service, Terri was a nonprofit lawyer in Miami, Florida, where she represented immigrant workers and co-hosted a Spanish language radio show on workers' rights.

Terri writes and speaks frequently on labor and workers' rights issues. She has authored numerous law review articles, think tank reports, and a book chapter, as well as scores of op-eds on

worker and labor issues in the New York Times, the Washington Post, CNN, Slate, Teen Vogue, The American Prospect, and other outlets. She has been interviewed on CNN, Democracy Now, National Public Radio, and in dozens of print media publications. Terri has also testified as an expert before the U.S. Senate Judiciary Committee, as well as several state legislatures. She is a member of the American Law Institute, and was the recipient of the Labor and Employment Relations Association 2024 Susan C. Eaton Scholar-Practitioner Award. Terri is a graduate of Harvard College and Harvard Law School.



### Samantha Magnani Deputy Assistant State's Attorney- Connecticut Division of Criminal Justice Hartford, CT Former Unit Chief of the Construction Crimes and Labor Fraud Unit/Assistant District Attorney Kings County District Attorney's Office

Samantha Magnani is a former Assistant District Attorney at the Kings County District Attorney's Office. She joined the Kings County District Attorney's Office in 1997 and just recently resigned to take another position in Connecticut. Ms. Magnani served as an Assistant DA and a Senior Assistant DA in Trial Bureau V and a First Deputy Bureau Chief in Trial Bureau V, where her primary responsibilities consisted of supervising approximately 30 junior and senior assistant trial attorneys, overseeing on-going investigations and conducting trials on violent felonies. After becoming a felony trial attorney in 1999, Ms. Magnani conducted in excess of 50 trials to verdict as either lead attorney or co-counsel and presented over 300 cases to grand juries.

Several of the more notable cases in which she was involved as lead attorney in Trial Bureau V have been the successful prosecution of the following cases: in 2016 of a man who hired a known drug dealer to set a fire in an occupied commercial and residential building at night be-

cause of a dispute with some of the occupants, in 2009 of a bodega owner in Brownsville responsible for the felony assault with a hammer upon a then 14 year old young man who went to purchase some food after a basketball game, and the successful prosecution in 2007 of three teenagers who robbed and beat to death an elderly 71 year old man in the Howard Houses who was waiting for the elevator in the lobby of 260 Stone Avenue.

During her tenure at the Kings County District Attorney's Office, Ms. Magnani also served as a liaison be-

tween the Kings County District Attorney's Office and the Juvenile Robbery Intervention Program (part of the NYPD) which was designed to rehabilitate and deter young defendants from further interaction with the criminal justice system. Ms. Magnani further served as a panelist once a month on the Cease Fire forum which was designed to deter parolees from further violent criminal activity. She also regularly attended the PSA 2 and 73 precinct community council meetings and assisted both members of the community and defendants (who are being offered court mandated programs) with direction and information to facilitate entry into community based programs and programs offered by the District Attorney's Office such as Center for Employment Opportunity, Cases and Fortune Society. Ms. Magnani also served as the DNA liaison between the prosecutors in her Bureau and the DNA Unit.

In 2016, Ms. Magnani transferred to the Investigations Division at the District Attorney's request to assist in creating a unit to focus on construction related homicide and labor fraud cases. Ms. Magnani served as the Unit Chief of the Construction Crimes and Labor Fraud Unit since its inception in 2019. Between 2016 and 2022, Ms. Magnani served as lead attorney on several major construction related investigations which were successfully indicted and prosecuted in the Kings County Supreme Court. The Unit currently handles all construction related fatalities and severe injury cases as well as all labor related fraud investigations.

Ms. Magnani is a graduate of Long Island University, CW Post Campus which she attended on a full academic scholarship and the University Of Richmond Law School in Richmond, Virginia. Ms. Magnani served as associate editor on the law review while at the University of Richmond. Prior to working at the Kings County District Attorney's Office, Ms. Magnani served as a law clerk for United States Magistrate Judge David Lowe in the Eastern District of Virginia. Ms. Magnani has also conducted training programs within her office on jury selection, opening statements and the presentation of evidence at trial. Ms. Magnani joined the Connecticut State's Attorney's Office in January of 2022 where she works as a prosecutor in the Hartford office prosecuting violent felony cases.

Rachana Pathak Chief of Worker Protection Unit Manhattan District Attorney's Office, NY

Rachana Pathak is the Chief of the Worker Protection Unit at the Manhattan District Attorney's Office. As a 20-year veteran of the office, Rachana Pathak brings a wealth of experience to this position. She has recovered millions of dollars in stolen wages for numerous workers, including most recently against the owners of Grimaldi's Pizzeria. She established a Stolen Wage Fund, the first of its kind, for employees who could not recoup their stolen wages through the normal processes (i.e., when employers declare bankruptcy). In addition to criminally prosecuting wage theft cases, she has prosecuted individuals and companies that create safety hazards, resulting in innocent workers' deaths. Most recently, she brought enterprise corruption and reckless endangerment charges against an OSHA training school that had issued more than 17,000 fake training certificates, which led to the death of a carpenter. Before that, in 2019, she secured top -count manslaughter convictions against the building owner, general contractor, and plumbers after the death of two individuals in the East Village gas explosion, a case that transformed the

way the City conducts gas inspections. Before that, in 2018, she secured a manslaughter conviction against SSC Highrise for the death of an employee after a scaffold fall and recouped \$517,000 in stolen wages for its workers. In 2015, she indicted 50 individuals, including 16 city employees, in a sprawling real estate bribery scheme. She has led the Construction Fraud Task Force since 2020, and has regularly collaborates with advocacy groups and city, state, and federal agencies to make these cases.



### Jeremy Pfetsch Criminal Enforcement Section Chief Labor New York State Attorney General Office

Jeremy Pfetsch is the Section Chief of the Criminal Enforcement Section in the Labor Bureau of the New York State Attorney General. The Section prosecutes cases of wage theft against employers who defraud workers of their pay, and other related criminal violations of New York Labor Law, including child labor violations and fraudulent schemes impacting workers. The Section also focuses on fraud and abuse in New York's public work programs. In addition to his work on criminal labor cases, Jeremy was a member of the Attorney General's Opioids Litigation Team, helping to build the team's case against the distributor companies, who settled with

the plaintiffs in 2021, shortly after the beginning of the civil liability trial in Suffolk County Supreme Court. He also assisted with the Labor Bureau's lawsuit against Amazon to protect warehouse workers' rights to health and safety during the global pandemic. Jeremy received two Louis J. Lefkowitz Memorial Awards for his work on behalf of the Office. Prior to joining the OAG in 2016, Jeremy was an Assistant District Attorney at the New York County District Attorney's Office for nine years, where he prosecuted a wide variety of cases including both violent and economic crimes, trying twenty cases to verdict. Jeremy holds a J.D. from Fordham University School of Law.



Kristine Hamann Executive Director Prosecutors' Center for Excellence

Kristine Hamann is the founder and Executive Director of Prosecutors' Center for Excellence (PCE). PCE provides consulting, assessments, publications, national meetings, independent case review and research services for prosecutors in offices of all sizes. PCE promotes best practices, spurs innovation and implements solutions on a wide variety of topics. Ms. Hamann chairs the National Best Practices Committee for prosecutors and the Best Practices Committee for the District Attorneys Association of the State of New York. She teaches a prosecutor practicum at Georgetown Law School. She is on the ABA Criminal Justice Journal Editorial Board and was a member of the ABA Criminal Justice Council. From 2013 to 2016, Kristine Hamann was a Visiting Fellow at the United States Department of Justice/Bureau of Justice Assistance pursuing best practices for prosecutors. From 2008 to 2013, Ms. Hamann was the Executive Assistant District Attorney for the Special Narcotics Prosecutor for the City of New York. From 2007 to 2008, Ms. Hamann was the New York State Inspector General. Prior to that Ms. Hamann served as the Executive Assistant DA to DA Robert Morgenthau in the Manhattan District Attorney's Office in New York City. Ms. Hamann held several other positions in that office including Deputy Chief of the Trial Division and Director of Training. She has received many awards for her public service, most recently the American Bar Association's Curtin-Maeling Minister of Justice Award (2024).

# **CLE Credit and Survey**



### Instructions to Receive CLE Credit Please Read Carefully

The Prosecutors' Center for Excellence has <u>not</u> requested continuing legal education accreditation for this program. Instead, we will supply you with a **Uniform Certificate of Attendance**.
